

Early Childhood Education Breaking News



At the Federal Level

- Congress considering a series of emergency funding bills 2 have passed and one now in debate in the Senate
- Including
 - early childhood education funding (through CCDBG)
 - emergency food assistance to food banks
 - Support for school systems
 - Support for health institutions
 - Support for state and local law enforcement
 - And much more



Across the Country

- Governors and state leaders are calling child care an essential service.
- States are scrambling to put emergency child care into action.
- Different actions -
 - Closed all child care
 - Relaxed child care standards
 - Setting up emergency child care sites for essential workers
 - Providing additional health and safety guidance
 - Providing additional financial support and funding



In North Carolina

DHHS/DCDEE has

- Passed a series of policies to guide the child care programs and others about best practices now. Posted on website.
- Working with the CCR&R network to track programs that are open and those that have closed on a daily basis
- Created a hotline 888-600-1685 to help people find child care who need it.
- Asked child care providers who are interested in becoming emergency child care sites for essential workers to complete interest application by March 31st.
- Putting together matching service for essential workers and available child care programs. Priority for children of critical workers.

DHHS/DCDEE COVID19 Response

Guidance to Early Childhood Programs

 How to make informed decisions about COVID-19 and minimize the risk of exposure to both the staff and the children in their care.

Financial Support

- **Child Care Subsidy**: all centers will receive full subsidy payment for each child enrolled in their facility according to each child's plan of care for the month of March.
- **NC Pre-K:** Pre-K programs will be paid in full for the entire month of March regardless of child attendance or closure.
- **Emergency Loans:** Gov. Cooper requested that the U.S. Small Business Administration grant North Carolina an emergency declaration that would allow for small businesses economically affected by the coronavirus to receive loans.



DHHS/DCDEE COVID19 Response

Regulatory Flexibility:

- DCDEE has identified policy and regulatory requirements that can be temporarily waived, while still ensuring the health, safety and well-being of children. (Chart on our website).
- All monitoring visits and environmental rated license assessments will not take place. This temporary change does not include investigations of complaints and investigations of child maltreatment

Creating Emergency Response Child Care System:

- Emergency Hot Line 888-600-1685 for critical workers to connect with available child care
- Asking child care programs to let DCDEE know if they are interested in becoming emergency child care sites.
 Required to meet new standard. Applications due March 31st.



NC General Assembly Action & Governor Cooper

NCGA

- House Speaker Moore created House Select Committee on COVID-19
- Taking comments at https://www.ncleg.gov/RequestForComments/33
- Nothing yet on the Senate Side

Governor Cooper

 Governor Cooper likely to call a special session once Congress has passed COVID-19 funding package.



NC Early Education Coalition Action

Emergency Child Care Funding Proposal

- Developing emergency child care assistance funding proposal to support early childhood education system now, during and after the crisis.
- Sending it to Governor Cooper and State Legislative Leaders

Call to Close Child Care Programs AND Provide Emergency \$ Relief Now

- Joint Action Coalition, NC Child, NCAEYC
- Our View this is a public health crisis and child care programs should be mandated to close just like public schools to protect the health and safety of children, families, early educators and communities.
