# 2022 Legislative Session

### 2022 Early Education Policy Priorities



- Child Care Workforce Compensation
  - Expand Child Care WAGE\$ statewide
- Child Care Subsidy Rates Improvements
  - Establish a statewide "floor" to provide adequate and equitable reimbursement rates
- Fund and Implement the Leandro Action Plan
  - Including expanded funding for Smart Start,
     NC Pre-K, Child Care Subsidy Assistance, Early
     Intervention, and more
- COVID Child Care Funding
  - Continue to invest in child care as opportunities arise



### Final Budget Summary for Early Education

#### **Good News**

- Child Care Subsidy rates raised to 2018 levels with federal American Rescue Plan funding
- NC Pre-K rates increased
- Smart Start administrative cap raised

#### **Bad News**

- No Child Care WAGE\$ expansion
- No Child Care Subsidy rates statewide floor
- No NC Pre-K expansion
- Does not include full funding for Leandro Plan



## Bright Spots in the Budget

#### Child Care Subsidy rates

- Reallocates a portion of the federal American Rescue Plan Act funding for child care subsidy assistance (\$206-215 million in the 2021 budget) to increase child care subsidy reimbursement rates to the 2018 market rate level
- Temporary funds will expire in September of 2024



## Bright Spots in the Budget

#### Smart Start:

Raises the cap for administrative costs from 8% to 9%.

#### NC Pre-K:

- \$9 million in recurring state funds to increase rates an additional 7% over the planned increase in the 2021 budget for a total increase of 9% this biennium with the intention of supporting salaries for NC Pre-K teachers in private child care programs.
- A portion of these funds will also be used to raise the reimbursement rate for public schools and Head Start programs by 5%.



### Other Child Care Action this Session

#### Additional Pathways for Early Childhood Credential (H159)

- Allows early childhood teachers to obtain a Child Development Associate (CDA) Credential from the National Council for Professional Recognition, or another accredited ECE Credential from one of five other ECE Credentialing organizations named in the bill.
- Directs the Community College system to design a test that would be an equivalency for a lead teacher requirement to teach in a licensed child care program in North Carolina.

#### Criminal Background Checks

- Aligns state criminal background checks for prospective child care providers with federal block grant requirements, which is a background check every 5 years rather than every 3 years
- End of the State of Emergency
  - Governor Cooper announced that the COVID-19 State of Emergency will end on August 15, 2022
  - Child care programs will have 6 months after that date to meet pre-pandemic staffing requirements



# What's Missing for Early Education

- Child Care WAGE\$ expansion
- More equitable Child Care Subsidy reimbursement rates with a statewide floor (H574)
- NC Pre-K expansion
- Full funding for early childhood components of the Leandro Plan
- Anything to sustain programs when federal support ends



### Think Babies™ NC this Session

#### Medicaid Expansion

- Not included in the final budget, but progress is being made!
- Senate and House leaders now both support expanding Medicaid, although they still disagree on some of the details
- Senate passed full Medicaid expansion this session; House isn't there yet

#### Other issues

• Despite the urgent need for infants, toddlers, and their families, no other prenatal-to-3 policy priorities — paid family leave, early intervention, home visiting, Earned Income Tax Credit, among others — were addressed during this legislative session



### Our Bottom Line Summary

- This budget represents a big missed opportunity for young children and families, and especially early educators!
- Invests too little not sufficient to address the current workforce crisis and the looming "cliff" when federal Child Care Stabilization Grants end
- Spends almost none of the \$6.2 billion surplus of state funds, which could have been used to support early education

# Update on Leandro

### What's the Latest?

- Leandro is a marathon, not a sprint!
- NC Supreme Court will hear oral arguments beginning August 31<sup>st</sup> regarding the court order to fully fund the Leandro Plan
- Amicus Brief signed by 144 organizations
- Just two years of the Leandro Plan includes approximately \$190M for early education:
  - \$71.9 M to expand NC Pre-K and improve rates
  - \$40 M for Smart Start
  - \$36 M to expand the Child Care WAGE\$ program
  - \$20 M to improve Child Care Subsidy reimbursement rates
  - \$18.45 M for early intervention
  - \$1.75 M for workforce recruitment strategies and professional development
  - \$1.7 M for early childhood workforce data system

# Federal Funding Updates

### Update on the Reconciliation Package

- As of now, child care is unlikely to be part of Congress' upcoming reconciliation package
  - Sen. Manchin has stated that he will only support a very narrow set of priorities, which doesn't include child care
  - Reconciliation is a Congressional maneuver to pass budgetrelated items with a simple 51 vote majority – cannot afford to lose a single Democratic vote
- It's not over 'til it's over...
- ...but NC has 2 Republican senators, which means there is little we can do to influence reconciliation

### Child Care Stabilization Grants

- Funded through the federal American Rescue Plan
- Quarterly payments to child care programs have been disbursed since fall of 2021:
  - Final payment will be disbursed in January of 2023
  - Will cover the January-April quarter
  - Funds can be spent through September of 2023

  - As individuals, no limitations; for nonprofits, must provide the same information and resources to all candidates running
